CORRIGENDUM

Subject: Amendment in the Guidelines for implementation of a scheme for setting- up of over 5,000 MW Grid-Connected Solar PV Power Projects with Viability Gap Funding (VGF) under Batch-IV of Phase II of the JNNSM - reg.

This has reference to the Guidelines for Implementation of a scheme for setting up of over 5000 MW Grid-connected SPV power projects under Batch-IV of JNNSM Phase-II, issued vide this Ministry's O.M. of even number dated 14-03-2016. The Guidelines (Specifically Para/Clause 4.4) is amended as follows:
